ADDENDUM NO. 2

The purpose of this addendum is to provide clarity regarding the intent of this RFP and to provide Proponents with a current list of inventory.

- Attached to this Addendum is Appendix K which offers a current inventory summary provided by the Receiver as of August 12, 2025. However, it must be understood that the store is still operating and inventory and its value will fluctuate.
- Several inquiries have been received regarding the historic financial performance of the current duty-free operation. The Authority instructs all Proponents that the Request for Proposals is a process to secure a new lease for a duty-free business operator, <u>not</u> the purchase of the existing business.

Financial performance can be influenced by several factors that are specific to each Proponent, including but not limited to: store offerings, vendor agreements, advertisement campaigns, capital investments, etc. As such, Proponents must not rely on past performance of the existing operations and instead rely upon their team to formulate a successful business plan.
